A History of St. Mogue's, Ballycanew

St. Mogue's Church of Ireland in the parish of Bally-canew, County Wexford, is the oldest extant church edifice in the Diocese of Ferns, and indeed, is among the oldest Protestant churches still in use in Ireland. Although the date of its erection remains unknown, it probably dates to the first quarter of the 18th century. Built in a traditional cruciform shape, its arched neoclassical windows reflect an Irish vernacular adaptation of the style made popular at the time by Sir Christopher Wren. Constructed of wood with a facade of stone, it has recently undergone an extensive restoration that included covering its walls with a stone-like exterior. It contains no monuments of great antiquity, and the earliest memorial inscriptions in the churchyard date to the mid 18th century.

Centrally located on a small hill in the village, St. Mogue's was probably built on a more ancient site of religious worship. P. H. Hore remarked that the present church "is said to occupy the site of the ancient one, but every remain of antiquity has long since disappeared from this locality." The Norman family of Neville, who occupied the parish from the 14th through 16th centuries, may have used the site for a chapel, although there are no surviving documents to support this contention. James Leslie notes that the Ballycanew rectory was part of the corps of the Ferns treasurer as early as 1409, which would seem to indicate that a church had been erected. By 1613, St. Mogue's had become a Protestant chapel, and a visitation book from that year indicated that it had "a

Common Prayer Book provided." The earliest known clergyman to serve the parish was Daniel Murphy, an Irishman, who was curate in 1613 and was listed as "a reading minister." By 1675, the parish was under the care of the Reverend Theophilus Williams, the licenced of Killulkelog, Killemehok, Kilrush, Mullymokin curate (Monomolin), Kilcavan and Ballycannoo. Nothing is known of Williams, and his tenure may have been brief. Within three years the parish was under the care of the Reverend William Burrell, curate of Christ Church, Gorey, who also served the parishes of Kilnehue, Kilcavan, Ballycanew, Mullomoling He had metriculated at Queen's (Monomolin), and Kiltrisk. College, Cambridge and received his orders in London in 1672. His service in Ireland was also brief, and by 1680 he had He died in 1704 at become rector of Great Parndon in Essex, the age of 57 and was buried at Morden.

The history of St. Mogue's a: the close of the 17th century remains obscure. The rectorship of Ballycanew became part of the duties of the diocesan treasurer, while a curate

was appointed specifically for Ballycanew and Kiltrisk. Burrell was succeded at Gorey by the Reverends Thomas Graves and William Moore, neither of whom apparently remained longer than a year. Nothing is known of their successors until well into the 18th century.

The earliest known clergyman to serve as rector was James Harvey, who was also appointed diocesan treasurer before 1720. Born at Killiane Castle, County Wexford in 1676, he had entered Trinity College in 1699 and had received his Master of Arts degree by 1707. He was ordained to the priesthood in 1709, and in 1720 was named curate of Killenagh, next of Ballycanew. St. Mogue's became one of several parishes Harvey served, but his activities specifically there remain unknown. He is listed as a pew holder in the parish in 1760, indicating that his role as a clergyman there may not have been an active one. Several curates served the church under his care, among them Edward Langford, who also served Mullomoling, Kiltrisk, and Killinick. He seems to have remained only through 1730, for the following year he was named curate of Gowran in the Diocese of Ossory.

By 1760, another curate, the Reverend Humphrey Hartley, had assumed the reins of the parish, but the date of his arrival is not known. Hartley had been born at Balloghan, County Carlow in 1711, a son of the Reverend William Hartley. Educated first by the Reverend Harffinch Piggott of New Ross, he later entered Trinity College in 1730 and received his Master's Degree by 1739. He was curate of Edermine in County Wexford in 1735 and may have been carate of several parishes concurrently. In 1739, an act of Council united the parishes of Ballycanew, Leskinfere, Mullamoling and Kiltrisk, and Hartley may have taken over the care of all four parishes soon after this date. He was certainly in Ballycanew before 1760, when he presided at the reassignment of pews on New Year's Day of that year. An active land holder, he appears frequently in the surviving leases for the village and maintained an estate at Tomgarr in the parish. He resigned his post due to frail health in 1780 and presumably died soon after, leaving a wife, Honor, and three sons.

James Harvey died in 1760, leaving vacant both the rectalship and the diocesan treasurer's post. The position fell next to the Reverend George Allen, another Wexford native. Born in the city of Wexford in 1711, he had entered Trinity College in 1729 and was there at the same time as Trinity College in 1729 and was there at the same time as Hartley. On being named treasurer of Ferns, he also spent time in his role as rector of Ballycanew and Kiltrisk. He presided at the vestry of 1761, of which only an abstract survives. He remained in office until his death in 1776, and his tombstone in Leskinfere churchyard described him as "Rector of the Union of Ballycanew."

Allen's successor, the Reverend Wensly Bond, had the longest term in office of any of his predecessors. The son of a Presbyterian minister of Corboy, County Longford, he had

entered Trinity College in 1761 at the age of 16. He received both a Bachelor's and a Master's Degree, and later attended Magdalen College, Oxford. Afterward, he was appointed Dean of Ross in 1773, and three years later was elevated to Ferns treasurer and rector of Ballycanew, Mullomoling, and Leskinfere.

Bond presided only irregularly at Ballycanew's vestry. He took little interest in collecting the parish cess, leaving this duty to his curates. He appeared usually to adjudicate in special parish matters, such as pew assignments and determining the need for church repairs. Hence, in 1802, he responded to a complaint that "many of the Inhabitants of Ballycanow and Kiltrisk, paying the parish cess, are not accommodated with pews in this Church, while other persons and families not living in either parish nor paying any parish cess occupy pews which they alledge to have a right to." He appears to have been fair-minded and usually sided with those parishioners who paid their cess and demanded pews.

Several curates served St. Mogue's under Bond's rectorship. When Humphrey Hartley retired at the end of 1780, he was succeeded by the Reverend Andrew Little, whose background is not known. He may have been related to Simon Little, who served as parish clerk. Almost nothing is known of Little's tenure in the parish; he seems to have been advanced in age at the time of his arrival in 1781. He continued the familiar admonishment of nonparishioners to pay the parish cess, or otherwise risk losing their pews, and he seems to have enjoyed considerable popularity. When he retired on July 23, 1792, the parish passed the following resolution:

Influenced by the humane, pious and unwearied Attention which has ever been zealously employed in discharging the important Duties of your Sacred Office, and likewise by the very honourable and trustworthy Disposal of such Monies as have at any Times been raised for the Parish Purposes, We the undernamed Protestant Parishioners of the above Union beg Leave to testify to you our sincere and un feigned Approbation of your Conduct hoping that you may long live happy to enjoy among us the Reverence and love which is equally due to your amiable private character as to your Public Virtue. Ballycancw July 18th.

The document was published in the Wexford Herald. Little

responded that the resolution was unexpected. "This friendly and unsolicited Testimony of your Approbation . . . makes me happy; my Heart feels it and thanks you for it, it will sooth the rugged and untrodden Part of my Journey through Life, which must needs be soon finished." By the end of 1792 he

had apparently departed from the parish.

The 1790s were a time of tumult in County Wexford for both the Catholic and Protestant populations, and the membership of St. Mogue's was not unaffected. The events of revolutionary France prompted an increase in United Irish activity in Ireland, leading many Protestants to feel increased anxiety. In November, 1792, a group of Protestants, meeting at the Crown and Anchor Tavern in London, passed a series of resolutions in response to what they perceived was the growing danger to the public peace "by the circulating of mischievious opinions," including the so-called Rights of Man, which threatened, in their view, the authority of Parliament.

Many of Wexford's gentry were anxious to secure the loyalty of the Protestant population in the wake of the Crown and Anchor resolutions, and the pressure was felt at Bally-Some of St. Mogue's parishioners were apparently members of the Ballycanew Social Harier Hunt, a fox hunting club with loyalist sympathies. At the urging of Hawtrey White, an intensely bigoted officer in the Yeomanry Corps with a strong antipathy for the native population, the club expressed in January, 1793 its "loya ty to their most gracious king and attachment to the constitution," and offered the "sincere and fervent prayers that he may long members' continue to reign over a free and happy people." In acknowledging the resolutions of London, the members expressed their desire to "recommend them the serious perusal and attention Publications dispersed with such wicked industry over the kingdom."

The minutes of St. Mogue's vestry are lost for most of the 1790s, so the level of anxiety within the congregation remains unknown, if indeed it was even expressed at the vestry. Whether the above resolution was coerced or reflected the genuine sentiment of the bulk of the parish inhabitants is also unclear. county Wexford had been influenced to some degree by the goals of the Volunteers of a decade before. In 1793 James Beaty, a millowner and parishioner, donated a tract of land next to St. Mogue's to the Roman Catholics of the parish for the construction of a chapel, an act which reflected some degree of altruïsm and cooperation. Lord Mount Norris was also known to be liberal with respect to Catholic toleration, so long as freedom of worship did not lead to revolution.

Arthur Colley assumed the post of curate as Andrew Little's successor late in 1792, amid this climate of fear and uncertainty. He had spent most of his life in Ballycanew and knew the people better than his predecessors. Born on the

townland of Bellcarrigg in 1762, his father, Roger Colley, had been a local farmer and pew holder, and at the time of his death in 1784 had left his son with a lease to a substantial farm. Nothing is known of Colley's education, although he seems to have been devoted to the welfare of his native parish. In his hand are written most of the vestry minutes which follow. He is joined frequently in the records by his brother-in-law, Christopher Harrison, who had married his sister Patience.

Ballycanew stood in the center of conflict during the Rebellion of 1798. Father Michael Murphy rallied his supporters from the Catholic chapel next to St. Mogue's, despite his congregation's pledge of loyalty to Lord Mount Norris in the spring of that year. A significant amount of firing occurred between British troops and the Catholic army near the parish, and several houses in the parish, Catholic and Protestant, were destroyed. Also burned was the Catholic chapel, although a portion of a wall that withstood the blaze was later incorporated into the Wesleyan chapel that was constructed later on the same site. Wensly Bond reported losses totaling 328 Irish pounds sterling, including his "house and offices, clothes, a gun, wine and spirits." Arthur Colley's losses were less significant, including "cattle, cloaths, provision, wine, and houses" totaling 83 pounds. Others in the parish reported even larger losses.

St. Mogue's itself was not apparently burned during the disturbances as was the Church of Ireland at Ferns. It did suffer from looting, however, and the parish register was stolen and presumed destroyed. Fragments of the shredded vestry book were recovered, and Colley recorded the loss of the remainder in a notation in the new book.

The appearance of the church at this time remains unknown. The only description from the period came from a visitor in 1790, who wrote in Walker's Hibernian Magazine:

I then rode . . . next to Ballicanow, a village, with a church, the yard of which being well planted with trees, gives the village a handsome appearance: near this is Nevills-court, the seat of Mr. Jones; opposite the front is a fish-pond, that supplies a boulting-mill kept by a Mr. Beatty. 12

The interior of the church was plain and included only a pulpit, altar, reading desk, and baptismal font. The original pews were evidently of the box style, and their upkeep was the responsibility of their owners. Of these fixtures, all but the font were replaced in the mid 13th century.

St. Mogue's congregation continued to grow in the early 19th century, and many parishioners were left without seats. Other pews were handed down through generations of families who were not parish residents. The amount of cess or tax collected by the parish also continued to increase, ranging from a total of 5 pounds in 1761 to 65 pounds (six pence per acre) by 1815. In 1807 the parish was required by law to

support a local militia, contributing a sufficient sum to support five substitute volunteers. More than 43 pounds were raised, which was substantial for the village but far less than neighboring parishes. (The contribution of Christ Church, Gorey was more than 113 pounds).

Wensly Bond took a strong interest in local affairs. When the dry goods store of James Floyd suffered a burglary of cloth and silk in 1813, he was among those townspeople pledging a reward for the capture of the thieves. He remained in office until his death in 1820, laboring at the end of his life to raise money for St. Mogue's renovation.

Colley remained curate through 1823, when he was named precentor for Leighlin and prebendary of Coulstuffe. He had several children, among them a son Arthur Junior who became a curate in Wexford. The elder Colley died in 1838 at his house at Bellcarkigg after more than thirty years of service in the parish.

The composition of St. Mogue's continued to change in the 19th century. Some families moved to America and Canada; new families arrived. The Wesleyan movement was particularly strong in Ballycanew and influenced many parishioners of long standing, including the Johnsons, Tackaberrys, and Taylors, to join the new church. Fossey Tackaberry, baptized in the parish in 1796, became a leading Methodist clergyman in Ireland. The administration of the church also continued to change, and in 1859 a perpetual curacy was established.

St. Mogue's continues to stand at this writing, altered in appearance somewhat from what it had been in the 18th and 19th centuries. Within the last several years it was renovated with a new cement-like exterior. The old churchyard has also undergone restoration. Currently the parish is served by the rector of Christ Church, Gorey, who also acts as the incumbent for Leskinfere. St. Mogue's continues to draw a small group of stalwart members from a radius of several miles surrounding the village of Ballycanew.

The Vestry

The vestry minutes included in this work provide a glimpse of the operation of small village Church of Ireland in County Wexford during the late 18th and early 19th centuries. The records are valuable not only because they exist (when those of many other parishes have not survived), but also because they are ordinary and without pretention. They reveal much about the structure of the church and the strata of society who supported it.

As was stated above, Ballycanew became part of the union of Mullomoling, Kiltrisk, and Millenagh in 1736. By 1760, however, the union included only Kiltrisk. The rector of the parish served several other parishes concurrently and was also diocesan treasurer. Beneath him was the curate, who held responsibility for the weekly operation of the parish,

conducting services and making entries in the parish register. He was paid from a stipend granted from the diocese, although the parish was responsible for the salaries of a parish clerk and sexton.

Ballycanew had what was termed a general or common vestry, rather than a representative vestry. Instead of being elected by the parishioners, it was comprised loosely of the parishioners themselves, who came together in an open setting to discuss the matters of the church. Meetings, also known as vestries, were held infrequently - always on Easter Tuesday and only irregularly on other occasions. The principal focus of the vestry was to elect churchwardens for the ensuing year and to determine the amount of cess or tax to be raised upon the acreage of every parishioner.

The office of churchwarden was not a coveted one in Ballycanew, and service in the post became a matter of duty The principal responsibility of the rather than choice. office was to collect the parish cess and present it to the curate within a year. The rector did not permit anyone to serve in the office twice; once one had completed a year's duty, he was not asked to serve again. Thus, in 1813, Samuel

Hollinsworth was appointed churchwarden "provided that he did not serve as church warden before." Paying the cess was not popular with local residents, and the increasing resentment

toward the collectors made the churchwarden disliked.

The vestry also appointed apploters for the parish, who would determine the amount of cess to be paid by each resi-This post carried more prestige, and there were no dent. limits imposed on length of service. The curate reserved the two posts for trusted parishioners, usually those having some means and literacy skills. James Beaty, Patt Cranwill, Christopher Harrison, and John Jones held the posts most frequently and were among the most prosperous in the parish of its middle class.

Participation in the affairs of St. Mogue's was limited to this middle strata of Protestant society. Lord Mount Norris played no role in its governance, except to present a gift of 35 pounds to buy plate in 1815. Large local landowners such as George Ogie, Roger Lyndon, William Clifford, and Thomas Colley were also exempt in deference to their station, although Lyndon and Colley both had pews, and Ogle was permitted to bury his wife in a place of honor directly behind the church.

The reason behind this exemption is unclear; it resulted from no apparent written rule. The men who gathered in the church for vestry tended to elect men of their own station as churchwardens. James Beaty was a mill owner; John Jones a prominent farmer; Leonard Bennett a saddler; James Floyd a shopkeeper; Christopher Harrison, Thomas Godkin and William Hawkins, tanners; Samuel and Nicholas Hollinsworth, farmers; James Jones, a silversmith. Charles Foley of Kiltrisk, a churchwarden in 1777, and Robert Harden of Cranacrour, a

churchwarden in 1804, were both illiterate and signed their names with marks. Others may have been literate enough only to sign their names. Few barriers existed within this class, and new men of humble beginnings could pass into it fluidly. Church government did not exclude them; indeed, it drafted a variety of men into its service.

Neither the churchwardens nor the parishioners played any role in determining worship style or church liturgy. These were left solely to the domain of the rector and bishop, taking direction from Canterbury. Preaching was strictly regulated, and the officiating clergyman could give sermons only by reading from one of several authorized texts. Communion was administered only on holy days and seldom at other times. Some churches had choirs and soloists beginning in the mid-18th century, but St. Mogue's apparently had no musical offering whatever until 1801, when Mrs. Mary Patchell was paid L1.2.9 for singing at Easter.

St. Mogue's, Ballycanew was a small, provincial church, with few of the amenities of its larger sister parishes at Gorey and Ferns. Even with the prayerbook, its services were austere and plain to more modern tastes. Sabbath-keeping was strongly encouraged, yet the church could not provide enough pews for those who wished to attend on Sundays. It was also a place, moreover, which offered a small measure of democracy to a group of mid-level farmers and merchants who were otherwise largely excluded from the political system.

About the Records

I have attempted in the following work to provide an exact transcript of the St. Mogue's vestry minute book which is housed in the church vault at Ballycanew. I have maintained original punctuation and spellings in nearly all instances, the only change being the substitution of the word "and" for "&" whenever it occurred in order to achieve greater legibility and ease in reading. I have also had to change the order of the book. When rebels tore the pages out of the original book during the Rebellion, a few leaves were recovered and sewn into a new volume. Most of these were restored out of sequence, which forced me to impose a chronological order upon them that differs from the order of the original volume.

I have taken considerably more liberty with the parish register, sections of which are nearly illegible and incomprehensible in the original volume. The earliest parish register included the records of Ballycanew, Kiltrisk, Killenagh, Monomolin, and Leskinfere. The curate often entered baptisms and burials on a single register page; at other times he would scatter these events over several pages out of sequence. To enhance their utility for the genealogist, I have placed them in a chronological sequence. The early dates are left in the old calendar style as they were

originally written.

Following the transcription I have included a facsimile of the actual text of the vestry book. The signatures of the parishioners have artifact value and may help researchers distinguish persons of the same name who appear in other records. It is my hope that this work will be of benefit to researchers interested in the families of Ballycanew Parish in the 18th and early 19th centuries. It is also my hope that this volume will be the first of several to appear for northern County Wexford.

The first of these is comprised of several fragments of the original parish register, which was destroyed during the Rebellion of 1798. The few pages to survive were sewn into the vestry minute book subsequent to this date. BYRNE. Sared to the memory of Honor Byrne Tomduff, who departed this life on the 15th August 1846 aged 70 years. This stone is placed by the Tomduff family to whom she was for 40 years a faithful and attached servant.

Here lieth the body of Patrick Byren, who departed this life April ye 8, 174-, aged 7-. [Stone now lost].

Here lies the body of Elizabeth Hollingsworth who departed this life Novr. the 6th 1784 agd 74 years and the body of John Hollingsworth of Ballinakill who depd this life May the 12th 1791 aged 78 yrs. Saml. Hollingsworth died Mar. 25th 1815 aged 48 yrs. Ann Hollingsworth, relict of Saml Hollingsworth, died April 1st 1849 aged 85 years.

Beneath this stone lieth the remains of Thomas Hollingsworth of Tomduff, who depd this life 7th June 1822 aged 82 years, also his wife Allis Hollingsworth who departed this life the 18th of July 1834 aged 82 years.

JONES. Table. To the memory of Margaret, the beloved wife of John Jones Esq. Tomduff late of Nevillscourt who departed this life Sept

1st 1865 aged 74 years, here also lie the remains of the above named John Jones Esq. who was was born in Nevillscourt July 7th 1794 died Sep 21st 1878.

Erected to the memory of John Jones of Coolock who departed this life 15th Decr 1879 aged 70 years, also his widow Anne who died 21st Sep. 1879 aged 60 years. [Cantwell's note: This grave is closed with a coped stone].

Erected to the memory of Shepherd Jones of Ballycanew who died 16th May 1879 aged 76 years. [Cantwell assumes that Shepherd was his occupation, but this is incorrect. It was his given name as proved by the 1821 Ballycanew census abstracts in the Philip Crossle' papers, National Archives of Ireland - editor].

KAVANAGH. Erected by Redmond Kavanagh of Carlow in memory of his father and mother, also his brother and sister, Here lies the body of Martin Kavanagh of Clone who depd this life Sept 29, 1808 in the 56th year of his age. Aslo his son William depd April 29th 1819 aged 39/49 [the 3 is superimposed over the 4] yrs, also his daughter Mary aged 15 yrs and his wife Allicia. May they rest in peace.

KEYS. [Cantwell's note: This headstone has an ionscription on the front and back, the latter being a sun burst and the letters IHS]. Erected by Patrick Keys of Clonmore in memory of his brother Edward Keys who depd this life Octr 26th 1827 aged 59 years, also his son Edward Keys depd Oct. 21st 1827 aged 59 years, also his son Edward Keys depd Oct 21st 1838 aged 23 years. "Stop passengers as you pass by, as you are now so once was I, as I am now so shall you bem prepare for death and follow me."

LACY-JONES. Here lieth the body of Michael Lacy esq. who depd this life July 11th 1802 aged 56 years. Here also lieth the body of Mr. James Jones who depd this life Nov. the 5th 1855 aged 75 years, also his wife Susan Jones who depd this life March the 25th 1840 aged 73? years.

McDANIEL. Here lieth the body of Moses McDaniel who depard this life Dec 26th 1794 aged 47 years.

MOORE. [Cantwell's note: This table (orledger?) is covered by a fallen iron railing and debris. Whilst I identified the inscription I could not confirm same, the following copied from J. Memorials Assoc.] Underneath this stone lie the mortal remains of John Moore Esq, late Lieutenant in His Majesty's Royal Navy, His afflicted widow precise rected the memorial Obt Mar. 25th 1810 etat: 39.

MOORHOUSE. Ledger. Here ieth the body of John Moorhouse who departed this life March 25th 1741? aged 32 years, also the body of Ann Moorhouse who departed this life January 11 1804 aged []

years, also the body of WilliamMoorhouse who departed this life Nov. the [], also the body of Thos Quinley [Quincey?] of Ballinarigg who depd this life June [] 1828 aged [75?] years. [Cantwell's note: a very lightly incised inscription].

MULLIGAN. Here lieth the body of Thomas Mulligan who depd this life the 18th of June 1813 aged 18 years.

NAUGHTER. Erected by Anne Naughter of Kilcorkey in memory of her mother Bridget Naughter who departed this life August 17th 1847 aged 25 years, also her brother Charles Naughter who died 12th June 1908 aged 87 years. Patrick Naughter died 6th March 1944 aged 78 yrs.

NOLANS. Erected by William Nolans Ballycanew in memory of his mother Maria Nolans who died March 21st 1837 aged 36, also his grandfather William Nolans who died D[ec?] 17th 1848 aged 78 years. Also his father James Nolans died Feb. 12th 1869 aged 74 yrs, also his wife Sarash H. Nolans died 8th March 1916 aged 68 yrs, also in fulness of time William Nolans was called to rest Oct 10th 1917 aged 85 years.

OGLE. For tables within an iron-railed enclosure]. Beneath this tomb are deposited the remains of the Right Honble George Ogle. He departed this life the 10th of August 1814 in the 72 year of his age.

Here is the same tomb which holds the remains of those she loved best on earth lies the body of Jane Moore Spinster who died on the 24th May 1831 aged 83? years.

Beneath this stone lie the mortal remains of Elizabeth Ogle wife of the Right Honourable George Ogle of Bellevue in this County and daughter of William ands Frances Moore who are deposited in the adjoining grave she died the 11th of August 1807 aged 65 years.

In memory of William Moore Esq of Tinrahin in this County who departed this life the [] of September 1756 aged [] and of his wife Mrs Frances Moore who departed this life the [] of December 1781 aged [73 or 75]. This humble tomb in testimony of her many virtues is raised by their greatful dutiful daughter Jane Moore.

PARKER. Ledger. Mrs. Mary Parker departed this life the 22nd of Feby 1790 aged 40 years, also her son Thomas Parker depd the life the 14th day of May 1834 aged [44?] years.

PATRICK. Erected by William Patrick of Ballywalter in memory of his mother Ellen Patrick who departed this life April 15th 1859 aged 66 years, also his father James Patrick depd this life November 4th 1860 aged 73 years, also the above William died 16th May 1868 aged 61 yrs also his brother Michael died 21st Feby 1900

aged 84 yrs. Catherine Fitzpatrick died 26th April 1938.

PORTER. Two tables side by side. To the memory of John Porter Esqr who died at Laburnum on the 16th June 1839 aged 49 years, he was an affectionate husband, fond father and sincere friend and to the memory of his only son William Benjamin who died the 28th of August 1822 aged 6 yrs and 6 months and to Susan/Sarah his second and youngest daughter, who died the 21st of June 1834 aged 9 years, and to the memory of Susanna wife of the above John Porter, who died on the 25th day of March 1850 aged 59 years.

Erected by William Benjamin Porter, Killenagh Park, in memory of his beloved brother John Porter who died July 14th 1856 aged 16 years, also his grandsons William B. Porter died 7th March 1913 aged 7 yrs, Ed Meredith Porter died 16th June 1935 aged 20 yrs, also their loving mother Martha Mary Porter, died 12th May 1943 aged 61 yrs.

Erected by William Porter in memory of his beloved father Benjamin Porter, [Killenagh?] Park, who died Nov 3rd 18[55?] aged [] years, also his beloved mother Mrs Jane Porter, who died July 25th 1850 aged 48 years.

ROBINSON. table. To the memory of the late Mr. William Robinson of Coolock in this county and of Coolmine in the County of Dublin, who depd this life the 16th Oct. 1799 in the 59th year of his age, also his beloved wife Mrs. Martha Robinson, depd this life 21st Jan. 1810 in the 50th year of her age, also their son Richd who died at the age of 5 years, also their son John Robinson Esq of Ushers Quay in the County of Dublin and late of Sandymount who depd this life the 11th of January 18[], aged [] years.

SMITH. Two ledgers side by side. Jane Brownrigg otherwise Smith departed this life May 12th 1776 aged 22 years, Dorothy Colley otherwise Smith depd this life Nov. 20th 1809 aged 95 years, Mary Goff otherwise Smith depd this life June 26th 1817 aged 62 years. Thjomas Smith depd this life [] 1777 aged 55 years, Anne Brown otherwise Smith depd this life 30th March 1786 aged 80, also beneath this tomb rest the remains of John Colley Smith Esq, Captain in Command of the Camolin Cavalry in the year 1798, who died at his residence at Camolin the 20th day of March 1837 aged 96 years.

STERNE. table. Here lieth the body of John Sterne who departed this life the 29th day of May 1729 and in the 55th year of his age, also the body of Thomas Sterne his son who departed this life the 17th day of June 1741 and in the 38th year of his age with 1 of his children, here lieth also the body of Thomas Sterne late of Ballyfoley who depd this life the 4th November 1806 aged 76 years, also his grandson Thomas Sterne who depd this life the 13th of

August 1837 aged 26 years, also his son William Sterne who departed this life the 26th of January 1847 in the 89th year of his age, also Margaret wife of the said William who depd 15th June 1850 aged 82 yrs.

TACKABERRY. [Cantwell's note: A group of nine memorials behind a low wall to left of the entrance to church.] Erected to the memory of Martha, widow of the late Thomas Tackaberry of Tomacaddy [sic] and only daughter of the late Richard Budd Clone Ferns, who depd this life 3rd Aug. 1880 aged 73 years, deeply regretted by her sorrowing children, her son Benjamin aged 15 years, her daughter Margaret aged 5 years, her daughter Elizabeth died 4th July 1892 aged 33 years.

Erected by Esther Tackaberry of Tomnigaddy [sic] in memory of her husband Samuel Tackaberry who departed this life 13th Decr. 1839 aged 76 years, the above Esther Rackaberry died 18[] aged 85 years, also their son Thomas died April 29th 1889 aged 82 years, his daughter-in-law Charlotte Tackaberry died 7th April 1877 aged 75 years, also her husband Fossey Tackaberry died 9th March 1888 aged 83 years.

In memory of Loftus Tackaberry of Tomagaddy who died the 20th day of June 1860 aged 14 years erected by his sorrowing parents, here also lies his beloved mother Sarah Tackaberry who died February 24th 1865 aged 37 years, also his father Fossey Tackaberry who died 6th November 1884 aged 76 years.

Table. Erected in memory of Benjm Tackaberry late of Tomagaddy who depd this life Janry 11th 1833 aged 612 years, also his wife Elizat Tackaberry who died June 29th 1855 aged 86 years, also his son Fossey Joseph Tackaberry who died Nov. 25th 1935 aged 58 years. Isabella Leipidge Lee, 1898-1954.

Coped stone. In memory of George Tackaberry of Wexford, who died in 1853, also of Mary Tackaberry his wife who died 15th December 1866.

Scrole. In loving memory of my dear husband Henry Giles Tackaberry, who died at Woodmount, Arklow 7th June 1913 aged 59 yrs.

Erected by Gretta and Deborah Erritt of Ballybenogue in memory of their father William Erritt, who died 13th June 1883 aged 79 years, also their mother Esther died 15th Dec. 1859 aged 49 years.

Coped stone. In loving memory of Samuel (Sam) Tackaberry, eldest son of the late Thomas and Martha Tackaberry died 18th of August 1902 aged 63 years, also his wife Mary died 24th May 1909 aged 70 years.

Coped stone with inscriptions on two slopes. To the loved memory of Susan Stavely youngest daughter of General Sir Charles Stavely G.C.B. and Lady Stavely, died at Glendalough March 22nd 1943 aged 61, also to Martha Tackaberry her life long friend. In loving memory of Martha Tackaberry, daughter of Thomas and Martha Tackaberry, called home March 13th 1943 aged 95.

WELDON. Here lies the body of Isaac Weldon who departed August ye 22d 1734 aged 50 years. Phebe Weldon died ye 29th of Sugst. in ye year 1755 aged 64 years. [This grave stone is lost].

WILLOUGHLY. Here lies the body of John Willoughly who depd this life August 2nd 1809 aged [] years. [This grave stone is lost].

WOODROOF. Vault surrounded by a low wall and topped by an iron railing.

Here lieth the body of Richard Woodroof of Gorey who depd this life the 7th day of March 1786 aged 78 years, also the body of Martha Hatton alias Woodroof, wife of the above Richard Woodroof depd this life July 30th 1799 aged 87, also the body of Abel Ram Woodroof Esq. son of the above Richard and Martha who departed this life December 20th 1811 aged 56 years, also the body of Martha Woodroof wife of the above Abel Ram Woodroof who depd this life 25th March 1825 aged 62 years, also the body of Abel Ram Woodroof, son of Abel Woodroof late of Gorey who depd this life [], also the body of John Woodroof who died October 15th 186[1 or 7] aged 67 years, also the body of Abel Woodroof Esq who died January 17, 1866 aged 73 years, Maria Morris died April 12, 1867 aged 39 years.

Here lies the body of William Woodroof of Glendoran in this county who depd this life the seventh day of September 1854 aged sixty eight years. This vault was erected in fulfilment of his wishes by his widow and his only child the Revd Abel Woodroof.
